\$TRIBUTE, the cryptocurrency of findom, femdom, & adult entertainment, is **revolutionizing the industry** by achieving what no content platform, payment app, hosting site, or crypto has ever attempted.

We believe that platforms and payment methods created for sex workers should be designed, built, and governed by sex workers. \$TRIBUTE is the first to establish a leadership team entirely composed of established sex workers with years of industry experience.

Our team's main goal is to develop the first decentralized app specifically for findom, an immensely profitable niche fetish that has been overlooked by other DeFi projects in the adult entertainment industry. Traditional adult content platforms gross millions of dollars per month from findom alone—illustrating the enormous market for an exclusive findom DApp integrated with smart contract games and features.

We are determined to meet the needs of this community, and \$TRIBUTE's unique approach to leadership will ensure that we solve the problems that sex workers have repeatedly faced on other platforms.



For Sex Workers, By Sex Workers.

Content creators, dominatrixes, cam models, & other sex workers are the lifeblood of the adult entertainment industry. And yet the power has always been concentrated in the hands of executives and corporate bureaucrats who frequently treat sex workers as pawns, each individual ultimately insignificant and expendable.

But sex workers are resilient. They have adapted to a myriad of restrictions and structural changes in the industry. They have built personal brands, fostered connections in the community, and founded their own businesses from the ground up. Established sex workers know the adult entertainment industry from every angle... and they know what changes would be most vital for the sex work community if power ever shifted into the right hands.

\$TRIBUTE believes the time has come for **new leadership**.

Ambassadors for \$TRIBUTE are all sex workers with expertise throughout the adult entertainment industry. But our team's Ambassadors are far more than just influencers using their platforms and photos to spread the word. All \$TRIBUTE Ambassadors are active managing partners on our project, comprising the first ever leadership team in the industry with only sex workers as members.

\$TRIBUTE accepts applications for ambassadorship from all established sex workers throughout the adult entertainment industry. Our team currently includes Ambassadors with years of experience in content creation, findom, femdom, camming, traditional porn, adult NFTs, and more. We are continuing to

expand our team with additional sex workers who can use their diverse industry experiences and keen business acumen to help guide the future of \$TRIBUTE.

Our team's goal is to develop three primary products for the sex work community:

- 1. A deflationary token on the Binance Smart Chain for use as a payment method throughout the sex work industry
 - 2. The first decentralized application (DApp) specifically for findom
 - 3. A content platform for findom, femdom, & adult entertainment

\$TRIBUTE Ambassadors will oversee the features and development of all stages of this project, ensuring that our platforms are able to solve the issues that sex workers repeatedly face. They will use their experience in the industry and connections to the community to continuously improve this project.

We are proud to be the first "For Sex Workers, By Sex Workers" project in the adult entertainment industry. It's time for change.

The obstacles sex workers face on content platforms and payment sites are so widespread that restrictions and unwarranted loss of income have become the new normal.

Many of the issues are caused by traditional financial institutions like credit card processors and banks that establish discriminatory policies banning users in the adult entertainment industry. Payment processors—including PayPal, Square, Stripe, Google Wallet, Venmo, Circle, and more—prohibit all forms of legal sex work in their terms of service and permanently shut down the accounts of content creators, models, dominatrixes, and erotica authors. Visa and Mastercard also have a long history prohibiting sex work and content creation that doesn't fit their "moral standards." New restrictions enacted in October 2021 resulted in mass censorship of legal fetish content and, ultimately, an unjustifiable loss of income for many content creators.

While existing content platforms may have their hands tied when it comes to protecting sex workers from Visa & Mastercard restrictions, content platforms DO have the power to prevent other injustices to the creators who fuel and sustain their businesses. Yet most choose to stand by platitudes like 'the customer is always right' rather than to protect the sex workers on their platforms. Sex workers lose significant income to **fraudulent customer** chargebacks and platform commission percentages as high as 40%, all while remaining vulnerable to being doxxed by data leaks, a constant safety threat on centralized platforms.

\$TRIBUTE envisions a new future for the adult entertainment industry.



The Future of the Industry

Our team is determined to **create solutions** for sex workers that completely eliminate these obstacles, as well as **offer exclusive features and games** that address the needs of both sex workers and clients throughout the adult entertainment industry.

Shattering Censorship

Other content platforms prohibit creators from selling completely legal fetish content because of the **discriminatory restrictions** imposed by payment processors and banks. This kind of **arbitrary kink-shaming** is both a violation of creators' freedom of expression and an attack on their ability to earn income selling popular fetish content.

\$TRIBUTE believes a sex worker-safe space is a censorship-free space.

Ensuring that creators have the **freedom to create fetish content** without restrictions from payment processors is one of \$TRIBUTE's top priorities. Our adult entertainment content platform will be fully integrated with Tribute Token, our cryptocurrency, so that creators are free to monetize their kink content without fear of censorship or account shutdown.



Abolishing Chargebacks

Imagine meeting a charismatic independent author and offering to buy a copy of their most recent novel. And then after you've finished enjoying every last page, you call your bank and deceptively report the charge as a mistake, keeping the copy of the book and securing a refund straight out of the pockets of the author.

Chargebacks are forced transaction reversals initiated by the cardholder's bank. They are meant as a buyer protection mechanism, but unfortunately, buyers often misuse them to fraudulently purchase adult content for free and exploit creators on traditional content platforms. Content creators continue to lose income for their work because of unjust loopholes that allow buyers to manipulate the system.

With \$TRIBUTE as a payment method, there will be **absolutely no chargebacks**. Sex workers using \$TRIBUTE as a payment method, enjoying the features & games on our findom DApp, or selling clips on our content platform will NEVER have to deal with fraudulent chargebacks again.

If customers have a legitimate concern with a custom clip they purchased or with content they paid for, they can **contact the creator** first about a solution. A payment method on and platforms backed by blockchain ensures that **we can promise creators no more chargebacks**.



Power over Payout Percentage

Content creators aren't the only ones who lose income from chargebacks and constant restrictions from traditional financial institutions. Platforms take on the **financial risk** that stems from their partnerships with discriminatory payment processors, as well as from chargebacks that occur on their sites. The universal solution on these content platforms has been to **impose exorbitant fees on content creators** to safeguard their own salaries and cost of business.

For example, OnlyFans takes a cut of 20% on every subscription, paid message, and tip, while Clips4Sale and iWantClips take 40% from creators on all content sold.

\$TRIBUTE does not depend on traditional financial institutions or have chargebacks, meaning we can offer content creators the high payout percentage they deserve. We are committed to keeping our fees as low as possible so that income stays in the hands of the creators who earned it.

Creators will have a 100% payout percentage on the games and features included in our findom DApp. On our adult entertainment content platform, creators will have a 100% payout percentage on tips and a 90% payout percentage on content sales.

The 10% fee on content sales will be used to pay for storage and hosting, as our platform will be a hybrid app and storage will be centralized.



Protecting Privacy

Doxxing is a **constant threat to the safety of sex workers**. The vast majority of sex workers build brands under aliases to protect their privacy. A data leak from a centralized content platform puts sex workers at risk of stalking, death threats, retaliatory involvement of friends and family, and permanent damage to "vanilla" careers.

Unfortunately, data leaks are far too common on traditional content platforms. In 2020, an iWantClips employee leaked the 1099 tax documents for all of its 2017 creators, which included their names, addresses, and partial social security numbers. In 2019, the data of over 1 million users of the adult site Luscious was leaked, many of whom had registered with government email addresses. In 2020, hackers shared a Google Drive folder containing 4 terabytes of stolen content from hundreds of OnlyFans creators, illustrating just how exposed these platforms are.

Customers throughout the adult entertainment industry also have valid privacy concerns. When a customer buys a paid message on OnlyFans and then sends the creator a tip, it's customary for a bank to put a hold on the customer's account due to the source of the charges. Customers must then call their banks if they want to continue purchasing content. This type of interference from the traditional financial sector is invasive and patronizing. Customers also have a right to privacy when participating in this industry.

A payment method on the blockchain ensures that both creators and customers using \$TRIBUTE stay anonymous.



The Future of the Industry

With \$TRIBUTE, no personal information is connected to payments or transaction history. Only the wallet addresses of creators and customers can be viewed on the blockchain. Creators can use \$TRIBUTE as a payment method without risk of identity exposure. Customers using \$TRIBUTE will similarly keep their identities private, while also gaining the freedom to spend their money as they see fit without interference from their banks.

Spotting Scammers

When content creators, cam models, and dominatrixes sell privately (that is, sell their content online to customers not using a formal content platform), occasional scammers attempt to con sex workers into giving them content or services for free. A common scam is sending falsified screenshots that make it appear as if this "customer" has sent money to one of the sex worker's payment methods. After the scammer has received the content or service, it becomes clear it was a con when the money never shows up in the account.

With \$TRIBUTE, it's **simple to verify** whether a customer has truly submitted a payment before sending content or providing services. All transactions on the blockchain are **public and 100% transparent**. \$TRIBUTE operates on the Binance Smart Chain, so payments are **extremely fast to execute**.



Instituting Instant Payouts

When creators are paid on traditional content platforms, they are unable to actually access their income until after a long "pending" period where the funds are screened for fraud and the platform waits for potential chargebacks. OnlyFans has a payout waiting period of 7-10 days, while iWantClips has a waiting period of one week in addition to only authorizing bi-monthly payments (unless creators want to pay extra). In certain countries, the waiting periods are even longer, and there are additional fees associated with accessing your own paycheck.

\$TRIBUTE will provide creators with **instant payouts** throughout our ecosystem. Whether creators are using \$TRIBUTE to sell content privately, earning tips through the games on our findom DApp, or selling clips on our adult entertainment content platform, the income they earn will be available immediately in their \$TRIBUTE wallet. No more payout period waiting time.



The First Findom DApp

Financial domination, or findom, is an **immensely profitable niche fetish** primarily practiced online. Financial submissives ("finsubs") enjoy the rush of sending large amounts of money to their Dominatrix. Sometimes finsubs prefer the thrill of sending their financial "**tributes**" anonymously for nothing in return; others seek out an arrangement that integrates other fetishes with findom, such as humiliation and chastity.

Findom is **often sidelined** in both the BDSM community and the sex work industry. Although content creators and dominatrixes who do not offer findom also charge for their work and time, the sheer amount of money paid to Findommes has made some erroneously characterize finsubs as powerless to make their own choices. Some people in the community can't fathom why someone would consent to this fetish, so they criticize what they don't understand.

In reality, findom is a fetish about **power exchange**, just like other fetishes enjoyed by dommes & subs in the BDSM community. In a capitalistic culture where men often feel like their value comes from how much money and power they have, some men find it very freeing to subvert societal norms by giving up their power—and money—to a Dominatrix. \$TRIBUTE believes that all dommes and subs in this community **deserve a space free from kink-shaming**.

The lack of spotlight on findom within the DeFi sector of the adult entertainment industry has carved out a unique opportunity to **create an exclusive product** for an overlooked community.



After our token launch, \$TRIBUTE will create the first decentralized application (DApp) specifically for the findom community. Our DApp will integrate smart contract games and features that make findom play even more enticing for both Findommes and finsubs, and offer practical solutions for streamlining business for Findommes, further increasing their earning potential.

Findom games are a hallmark community attraction that captivate finsubs as a favorite form of entertainment and bonding with a Findomme. Many popular games have been used throughout the findom community for years. Currently, there is no integration between the app the Findomme uses to design the game, the app the Findomme & finsub play the

game on, and the app used to collect the payment for the game. Findommes typically collect a deposit before beginning a game, but since all of these aspects occur on different platforms, finsubs can simply disappear after they finished playing without paying the full amount they owe.

\$TRIBUTE's DApp will resolve these issues by **fully integrating** the findom game play experience. Our DApp will have all the best findom games and features **all in one spot**.

Imagine... Permanent Ownership Contracts

When a sub is ready to commit to serving his Domme long-term, he signs an ownership contract stating that she officially "owns" him and pays her an ownership fee. Traditionally, Dommes write and manage these ownership contracts themselves, and a sub can usually pay an additional fee to break the contract early. But imagine ownership through a smart contract... all easily accessible through our findom DApp. After a sub agrees to the terms of the contract and pays the fee to his Domme, the ownership contract is permanently written on the blockchain.

Imagine... Debt Contracts Made Simple

Many finsubs love being locked into a debt contract with their Domme. The weight of the growing interest on a large balance makes subs feel like a Domme will have power over them forever. Currently, Dommes create their own spreadsheets for each sub, keep track of payments, and remind & punish forgetful subs. But imagine a DApp with debt contract templates a Domme wallet can easily modify and send to her sub to accept & connect to with his wallet. The debt contract would automatically deduct daily, weekly, or monthly payments depending on the configuration. The Domme and sub could even agree to add punishments to the contract. Late payment due to insufficient wallet balance? Double payment due next week or x amount added to total balance.



The First Content Platform Created & Managed By Sex Workers

2021 was a tumultuous year for content creators. In August, OnlyFans announced they would be **banning all explicit content** to appease their financial partners, then reversed their decision days later after a massive backlash from the sex work community responsible for the start-up's financial success. AVN Stars and GayVN Stars, two content platforms operated by AVN Media Network, announced in December that they would be **discontinuing all monetization features** due to banking discrimination, resulting in a **permanent loss of income** for many creators.

The biggest blow came from the **new Mastercard regulations** enacted in October. These **discriminatory restrictions** forced platforms to place additional bans on legal fetish content, as well as lock up creators' content for manual review. Months later, many creators are still unable to sell their content while it continues to sit "**pending review**." As new restrictions are stacked on to old ones and even some of the sturdiest platforms collapse under the weight, content creators often try to safeguard their incomes by diversifying and establishing themselves across many platforms.

Yet all conventional content platforms depend on partnerships with these payment processors, leaving the future for creators uncertain.



\$TRIBUTE wants to offer an alternative for content creators. As the first content platform ever created and managed entirely by sex workers, we are committed to solving the problems that matter most to our community. Our content platform will only accept cryptocurrency, ensuring that our creators can receive instant payouts, sell legal fetish content without discriminatory censorship, and be completely free from chargebacks.

Passing on payment processors also means taking on **far less financial risk** as a platform... and we plan on passing on that savings to our content creators. Creators fuel this industry and deserve the **highest payout percentage possible**. Our content platform will have a **100% payout percentage on tips** and a **90% payout percentage on content sales**. We will use the 10% fee on content sales to pay for storage and hosting costs, as our platform will be hybrid and storage will be centralized.

\$TRIBUTE is by sex workers, and FOR sex workers. Tribute Token, our cryptocurrency, is designed to automatically reward all content creators on our platform. 1% of every transaction will be divided equally among all active creators, offering an additional way to earn passive income every single time our token is traded.



All features on our content platform will be determined by our team of Ambassadors—established sex workers from a variety of areas within the adult entertainment industry who have close connections to the community.

Some of the features include:

- Subscribing to creator pages
- Ability to send tips without subscribing
- Clips
- Links (paid & unpaid)
- Paid messages
- Paid block/unblock
- Discount/markup codes
- Paid/unpaid image galleries
- Paid/unpaid video content

Our platform will have **centralized KYC checks** to ensure that no illegal content is posted on our platform, as well as all content creators and performers are 18+.

\$TRIBUTE firmly believes that the restrictions on fetish content are discriminatory and represent an unjustified targeting of the adult entertainment industry under false pretenses. Our team, and our community, supports age verification and consent. As we develop this platform, \$TRIBUTE will remain committed to regulating content in ways that do not censor the fetishes of consenting adults.



Crypto Education

\$TRIBUTE Ambassadors are passionate about **supporting the sex work community** that they belong to and believe that a greater understanding of **cryptocurrency is critical** for sex workers today.

One of the goals of our team is to provide **free crypto education** for members of the sex work community. We want to provide resources that **uncomplicate crypto** for sex workers and their customers, all **created by fellow sex workers** who understand how toxic many male-dominated crypto and trading spaces can be for newcomers who want to learn.

Our "Crypto 101" resources include video tutorials, infographics, FAQs. and more.





\$TRIBUTE has developed a tokenomics strategy that honors our commitment to low fees while establishing an optimal path for continued growth in price and demand. Part of our strategy includes automatically rewarding all Tribute Token holders on every transaction, offering a passive income opportunity for our investors.

\$TRIBUTE also believes in giving back to sex workers who are indispensable to our future. When our content platform launches, all active content creators will automatically receive rewards on every token transaction.



\$TRIBUTE follows a **deflationary model**, automatically burning 1% of each transaction to support the token's long-term value.

Our team knows that the most important part of our strategy for token growth is **expanding our ecosystem** and delivering exceptional projects for the community that will be utilized for many years to come. Our **leadership team**, entirely composed of sex workers, that actively manages and markets all facets of the \$TRIBUTE ecosystem is funded solely through transaction fees, ensuring their continued commitment to the **growth of this token**.

Initially, the maintenance tax will be used for development of our content platform and findom DApp, bolstering the maintenance wallet for a **faster roll-out**.

After both projects have been released and half of the tax has been reallocated to every sex worker using our platform, the rest will be used to fund the **development of new features**, improve user experience, and expand marketing for the benefit of all our creators.



Token Distribution

There is a total supply of 10 billion \$TRIBUTE.

The rates for our Private Sale, Public Pre-Sale on DxSale, and start of trading on PancakeSwap will be as follows:

Private Sale: 1 BNB = 3,050,000 \$TRIBUTE (250 BNB)
Public Pre-Sale: 1 BNB = 2,850,000 \$TRIBUTE (1500 BNB)

PancakeSwap: 1 BNB = 2,650,000 \$TRIBUTE

Liquidity will be locked for **one year**, after which it will be locked again as needed.




Token Distribution

The developer wallet is only **5%** and will be locked for 3 months. Our marketing wallet is also **5%** and will be used for promotions, partnerships as well as airdrop.

Funds generated from Pre-Sale will be used for hiring additional developers to maintain both our DApp and content platform.



Roadmap

Our roadmap is divided into quarters, starting with Q1. Each quarter shows what our main priorities are for managing this project.



\$TRIBUTE's marketing strategy is centered on **engagement and growth** primarily within the sex work industry. Content creators & their fans, Findommes & their funsubs, Dominatrixes and their subs—the \$TRIBUTE ecosystem is being developed for them, and we want our marketing to **encourage community conversation** on the future of adult entertainment.

Airdrops

1% of the total supply of Tribute Token is reserved solely for airdrops (100 million tokens), rewarding those who help spread the word.

Community Engagement

Our team of Ambassadors are active on our Discord server and regularly available to **answer questions** about \$TRIBUTE, talk about our "Crypto 101" resources, and chat with newcomers. We also host AMAs (**Ask Me Anything**) to discuss updates and **hear back from the community** about what features matter most to them for our upcoming DApp and content platform.



Partnerships

\$TRIBUTE is committed to making partnerships with **influencers** in the sex work community as we continue to grow. Prior to our Pre-Sale, we have already built partnerships with the first and biggest findom Discord server, as well as the biggest femdom discord server.

Merch

We know that merch is an important part of **fostering brand recognition**, so we launched our merch site during Q1 of 2022 prior to our Public Pre-Sale.

Social Media

Our active Social Media Team will make sure that \$TRIBUTE continues to grow. In addition to expanding our presence on Twitter, our team is developing marketing strategies for TikTok, Instagram, and Reddit.

Events & Outreach

After the launch of our findom DApp, our team will present at Fetish Con, crypto conferences, and other community events.
